College Position on Award of the Edmund Rice Scholarships

An Edmund Rice Scholarship is defined as:

- x A full or partial exemption from paying tuition fees set by the College
- x The awarding of an Edmund Rice Scholarship does not exempt families from all financial obligations to the College.

An Edmund Rice Scholarship may be allocated at the discretion of the College Scholarship Committee in the following circumstances:

- The student achieves an acceptable academic standard (as determined by the Principal at his absolute discretion)
- x The student is able to contribute to t he life of the College via co -curricular activities, liturgy, social justice, the arts and/or leadership.

The parents or guardians are asked to:

- x Complete the application form and return it to the College.
- x Collect and submit the relevant documen tation to s upport the Statement to the satisfaction of the College Scholarship Committee

The College Position on award of the Edmund Rice Scholarship is directly related to the Concession Policy (May 2015) and will be awarded in consideration of the following mat ters:

- x St PiusX College is part of Edmund Rice Education Australia (EREA) which operates within the mission of the Church in which every child is entitled to a n Education.
- x Every school faces the challenge of achieving equity and fairness in relation to the setting and collection of fees.
- x The College is a non -profit organisation where expenses are shared by all parents.
- x As a Catholic school, income is received from Government grants, school fees and fundraising.
- x The level of fees charged must be sufficient t o support the educational program of the College.
- x Students enrolled at the College come from a range of backgrounds and a variety of socio economic circumstances.
- x Parents who enrol their sons at St Pius XCollege do so with the knowledge of their financial obligations.

- x Willingness on the part of parents to provide current, accurate evidence of hardship.
- x A commitment by parents to upda te the College in relation to their financial situation.
- x The timely payment of any partial contribution in accordance with the agreement.

In the case of financial hardship being assessed and confirmed, the College may offer payment plans, fee concession an d, in the most needy cases, a Scholarship. All are approved at the absolute discretion of the Principal with advice from relevant committees . The College budget is set out to ensure that funds are available to assist those families experiencing financial difficulties.
